
# Safer Solihull Partnership

The Solihull aspiration is less than 1000 crimes recorded in a month but levels have been above this for the past 5 months

# **Current Performance**

Making our neighbourhoods safer places:

**Strategic Locations** - Crime figures for our four strategic locations in comparison to year to date 2015/16 as at  $1^{st}$  January 2017

- Chelmsley Town Partnership Plus up by 91 (1,380 recorded crimes)
- Smiths Wood Partnership Plus up by 36 (387 recorded crimes)
- Solihull Town up by 89 (760 recorded crimes)
- Shirley Town up by 95 (600 recorded crimes)

**Tackling Drug Misuse** - *Indicator definition*: The number of new referrals to structured treatment in the month divided by the number of clients on the SIAS caseload in structured treatment in month.

**Performance commentary 2016/17:** Performance increased significantly in October, up to 89.74%, (35/39 clients) achieving both the minimum performance standard and aspirational target. *SIAS Update (Dec 2016)*: Links have been improved with court teams which has improved clients outcomes and response from service. Pro - active cell sweeps have continued.

## **Road Safety**

The latest position of the Borough is that between January 2016 and November 2016 there have been 44 people killed or seriously injured on our roads (2 fatal). **Solihull's Road Safety Strategy 2017 to 2030 is currently in draft format. Whilst en**gineering measures are used to prevent further collisions increasingly we need to place more emphasis on educating road users to change risky behaviours.

Speed Check activity continues co-ordinated by the SMBC Neighbourhood Co-ordinators and results are often reported on twitter.

MAVE (Multi Agency Vehicle Exercise) operations are also continuing. Agencies involved include Immigration, Solihull Licensing Department, Trading Standards, Solihull Police, Warrants Officers, Central Police Motorway Group, DVSA and HMRC.

## **Supporting Stronger Communities:**

#### **Burglary Dwelling**

Briefing Date 30 January 2017 - Comparison to the same time in 2015/16 up by 267 to 933 (+40.1 %). A partnership plan has been developed and there are weekly meetings to discuss progress against the plan.

Hate Crime Briefing Date 30 January 2017 - Comparison to the same time in 2015/16 up by 28 to 170 (+19.7 %).

# Better protecting people from harm:

**Total Recorded Crime** - Briefing Date 30 January 2017 - Comparison to the same time in 2015/16 up by 1061 to 11,010 (+10.7 %)

**Domestic Abuse** - Briefing Date 30 January 2017 – Number of Domestic Violence crimes in comparison to the same time in 2015/16 up by 65 to 969 (+7.2 %)

Partners participated in the 16 Days of Action Against Domestic Violence which ran from 25 November to 10 December 2016 aimed at business to positively address domestic abuse throughout the workplace.

A nominated Offender Manager is now attending MARAC which has improved the management of Domestic Abuse offenders in Solihull.

**Anti-Social Behaviour -** Cross tenure ASB service working with partners across public spaces and communal areas.

SCH are now using a Noise App as a way of dealing more effectively with complaints.

Child Sexual Exploitation (CSE) - info is collated on a regional basis & regular snapshots of the nature and scale of CSE across Solihull is circulated monthly internally &reported quarterly to regional co-ordinators.CSE Operational Groups meet regularly to assess priorities and progress. Solihull's action plan compliments the work being done regionally. Currently 97 young people are regarding as at risk of Child Sexual Exploitation in Solihull. Of the 97 cases 12.3% are risk assessed as level 2/3 risk level. Awareness Training has been given to nearly all Solihull taxi drivers and work is in progress to make it mandatory training, PACE training is also currently been rolled out across all Solihull schools. Raised awareness is helping to identify CSE risks early; our data supports this theory as majority of our cases are risk assessed as risk level 1. All level 1 cases have access to early help interventions via our early help partners. Level 2/3 cases have access to CSE direct work via the specialist CSE team. #### **Demand Locations**

- ✓ Box Clever providing diversion activities in Smiths Wood and Shirley. A new free to the public project has been developed for the Hobs Moat area beginning February 2017
- ✓ Referrals continue to Age Concern
- ✓ During Road Safety Week 21-27 November 2016 the partnersran operations to spot drivers who were using their mobile phone or not wearing a seatbelt and offered them the opportunity to experience the consequence of a serious road crash via virtual reality headsets. Checks were also carried out on taxis to check they are roadworthy with drivers suspended if their vehicles were in a poor condition
- ✓ Partners worked together to support the Christmas Hamper Appeal identifying vulnerable residents

## **Other Activities**

- ✓ The system for identifying and engaging drug and alcohol users in the criminal justice system has been reviewed and pathways between criminal justice partners and SIAS have been revised
- ✓ The SIAS Criminal Justice team case hold criminal justice clients to ensure they have a named worker providing additional support to access and engage in drug and alcohol treatment and the recovery services
- ✓ The SIAS Criminal Justice team are also case holding clients in prison to ensure the transition into the community and treatment on release is as easy and seamless as is possible to avoid relapse.

## Bringing offenders to justice and tackling re-offending:

#### **Integrated Offender Management (IOM)**

On January 1<sup>st</sup> 2017 the ID-IOM data (the Police National Computer based tool that converts re-offending rates in to cost) shows the following:

- 230 Managed Offenders for Solihull IOM 212 Male and 18 Female
- Current IOM activity projects a reduction of 34.8% in the daily average re-offending rate of each Managed Offender. This equates to a saving of £1,125,229 in Criminal Justice costs
- This evidences a significant uplift in performance through 2016 (in early 2016 IDIOM projected savings under £250,000)

#### **IOM Updates**

- 1. The IOM department is realigned to target resources on highest risk offender and increase focus on Youth Intervention (aligned to WMP 2020)
- 2. IOM now also managing Sex Offenders and Domestic Abuse Perpetrators
- 3. Restorative Justice The IOM RJ pilot is now underway with its first three month review being February 16<sup>th</sup>.
- 4. Prevention and Intervention Developing a borough wide 'Prevention culture' including promotion of prevention and intervention pathways continues. There has been excellent joint working between Police, Engage and WMFS. Engage and Police Response now have a sustainable 'prevention' relationship.
- 5. A number of innovative projects and academic trials are underway including 'Fresh Start' ('Growth Mindset' behavioural change letters being sent to offenders) and 'National Prison Radio' (A collaboration with the BBC and National Prison Radio Charity to promote IOM via a trusted medium in Prisons).

### Young People (figures published by Youth Justice Board)

The Youth Offending and Prevention Service (YOPS) have a statutory duty to report on the performance indicators for young people entering into the criminal justice system as youths. YOPS produce a quarterly dashboard which reports on the three statutory indicators including:

- First time entrants: reduction in FTE in Q2 2016-2017 compared to quarter 1 and 2 in 2015-2016 by 28%
- Rate of reoffending: 0.1 % increase in reoffending rate
- Rate of custody and remand: reduction n in custodial rate

The data is submitted to the Youth Justice Board on a quarterly basis. The published performance is owned and governed by the YOPS Management Board. Quarter 3 performance data will be published in February; Quarter 4 performance report will be available at the end of May. The report being presented at the Safer Solihull Board will be that of Quarter 1 and 2 accumulative. See attached dashboard
